Thank you for your recent request for information from 3M's Electronic Materials & Solutions Division (3M EMSD) related to the on-going COVID-19 situation and its impact on our operations.

3M is closely monitoring developments associated with the 2019 Novel Coronavirus. We are also closely monitoring and responding to any potential impact to our broader supply chain. While the situation is dynamic and continues to evolve, we are actively working with our customers to enable supply of product for open orders and updating expected ship dates and lead times if needed. Any updates can be found on bCom or by contacting customer service. If you are not currently registered for a bCom account, please contact your Customer Service team for a registration code and instructions on how to sign up.

We realize that continuity of supply is important and we have implemented measures, as part of our business continuity plans, to minimize the risk of disruption during these unsettled times. These plans include risk assessments, internal and external communications, and steps required to return to normal business operations from any impact. Additionally a COVID-19 Preparedness Plan has been developed across all sites focusing on real time situation monitoring, risk mitigation, and continuity of operations. Included in this is a 3M Disease Prevention Coordinator who will be responsible for local infection management and communication with employees and 3M Occupational Medicine in the event of any illness.

We are currently aligning our internal practices to recommendations from the Centers for Disease Control. This includes defining "high risk" as persons as having traveled from a Level 3 or high-risk location or having known exposure to a person with a suspected or confirmed case of COVID-19. Individuals to whom these "high risk" scenarios apply must notify the Corporation and self-monitor at home for 14 days.
